The Big Picture

Traditionally, the US has been the largest petrochemical producer, accounting for a fifth of total petrochemical sector oil consumption, with the Middle East being the second most important producer (representing 15% of global oil consumption for petrochemicals). The EU accounts for 14% of petrochemical oil consumption, China (13%), Korea (8%) and Japan (6%), where petrochemicals are largely produced from naphtha.

Is Canada's petrochemical sector well positioned to compete globally? Based on the short and long-term forecasts, the abundance of feedstock available in Alberta and British Columbia and the potential to adapt the existing logistics network for increased exports, what does the outlook for Canada's petrochemical industry look like on a global scale? Are the challenges in Western Canada the same as in Central Canada? Does the Marcellus production tidal wave raise the fortunes of petrochemical facilities in Ontario?
